Minutes of the May 22, 2017 Membership Meeting

The May 22nd meeting was a joint meeting of SOECA and Park Hills Civic Association. Representatives from State and Local government and from Purple Line Transit Partners were present to brief residents on legislative activities and on the light rail project.

Prior to the presentations, Michael Bufalini presided over a brief SOECA business session:

Minutes of Previous Meeting: The minutes of the April 4, 2017 meeting were approved.

Treasurer's Report: David Hartmann reported a balance of \$7,546.68 in the checking account. Expenses in April and May were \$515.72 for meeting room rentals and production of 2 newsletters. Eight members paid dues in the April/May period, and the next annual membership drive will be in September/October of this year.

Announcements: Anne Vorce invited everyone to the Friends of Sligo Creek Bike Ride for Clean Water on June 4th. Details can be found on the website of Friends of Sligo Creek.

Resolution regarding Queen Anne's Drive: Michael Bufalini read a motion concerning traffic and pedestrian changes on Queen Anne's Drive. Jeff Ensor, a resident of Queen Anne's Drive and the leader of the effort to put traffic/pedestrian changes in place, joined Mr. Bufalini in answering several questions. It was noted that the resolution documents SOECA's support for a request to the County to consider several changes to Queen Anne's Drive. The changes are designed to improve safety for pedestrians and vehicular traffic. Mr. Ensor noted that over 50% of the residents on Queen Anne's Drive support the proposed changes. The resolution passed on a vote of 14 in favor and 6 opposed.

Election of Officers: Michael Gurwitz, SOECA Vice President, presented the following slate of officers for the coming year:

The slate of officers was passed by a unanimous vote.

Presentation by Representatives of State and Local Government: Delegates Jheanelle Wilkins and David

Moon and Senator Will Smith briefed the membership on the recently-concluded legislative session in Annapolis. Their presentation was followed by one from County Councilmembers Tom Hucker, Marc Elrich, and Hans Riemer on the County budget for the coming fiscal year and on their recent legislative accomplishments. Councilmember Hucker announced that the County had just signed a new contract for trash removal in Silver Spring due to the considerable number of service complaints filed by residents against the current contractor.

Presentation on the Purple Line: Representatives from Purple Line Transit Partners and from the MTA's Purple Line Management Team were on hand to make a presentation on the light rail project.

Mr. Madden started the presentation by discussing various activities that are currently underway; the timeframe for construction and operation of the system; the siting of the Traction Power Substation; and improvements to a school parking lot and to the area buses would use to drop off/pick up students. He noted that the light rail vehicles will be modular, articulated to accommodate sharp turns, 139' long, seat 80 passengers, and be able to carry bikes. Trains will run approximately every 7-1/2 minutes.

Mr. Madden reviewed the revised design for the Dale Drive/Wayne Avenue station. One major improvement was to reduce the width of Wayne Avenue by approximately 10'. Other changes include a reduction in the height and length of a retaining wall; installation of a pedestrian refuge in the middle of Wayne Avenue; use of pedestrian countdown timers; the use of safety personnel during student arrival and dismissal times; and installation of lighting, railings, and use of closed circuit TVs to increase safety.

Several residents asked for the justification for the station at Dale Drive/Wayne Avenue. Mr. Madden indicated that many people in the community wanted this station.

In response to questions about how the Purple Line would affect car, bus, and truck traffic and parking on residential streets, Mr. Madden said that the trains would not interfere with left turning traffic or with school buses arriving at/departing from the schools. The State has asked Montgomery County to consider prohibiting trucks from using Dale Drive from Wayne Avenue to Piney Branch Parkway.

3 September 2017

Great concern was expressed by residents about speeding on Wayne Avenue and Dale Drive.
Mr. Madden noted that the speed limit on Wayne Avenue has been reduced to 25 MPH and he asked residents to contact the County Police about their concerns with enforcement of traffic laws and traffic cameras.

Several residents expressed concerns about environmental issues. Mr. Madden said all parties involved in this project are adhering to light rail rules and regulations. While usually not shared publicly, Stan Edwards of the Montgomery County Department of Environmental Protection will share a copy of the project's storm water management plan with SOECA.

Residents asked about "wheel squeal" and were informed that while there is the potential for this in "a couple of places" project management does not believe it will be a problem. Residents wanted to know why a Traction Power Substation had to be placed in our neighborhood. Mr. Madden indicated that the placement of substations was dictated by the need to situate one roughly every two miles along the route.

Regarding the construction schedule, Ms. Carla Julian of Purple Line Transit Partners indicated the workday will span 7am to 7pm with some night and weekend work.

Mr. Bufalini thanked Mr. Madden and his associates for the presentation. He indicated that questions had been solicited in advance of the meeting and those questions will be given to Mr. Madden so answers can be prepared and returned to SOECA to share with its members.

The meeting adjourned at 9pm.

The Environment

This summer, our neighborhood once again let us experience the wonder of nature without getting in a car. Yellow crested night herons, ducks and hawks fished in our creek; deer and red fox were seen by many. Neighbors got in on the action and in early June around 70 hearty nature lovers celebrated our watershed by riding in the Friends of Sligo Creek's Second Community Bike Ride for Clean Water. Riders followed the Anacostia Tributary Trail System from

the head waters of Sligo Creek to the Anacostia River and back.

While there is much to admire in Sligo Creek Park there is pollution too. The source isn't always known but problems have been seen near the stage on Ellsworth Drive, the Wayne Avenue parking garage and around WSSC's road work.

Please help us protect Sligo Creek by being a Friends of Sligo Creek Water Watchdog. If you see pollution in Sligo Creek, in one of our tributaries feeding the Creek or on the street heading into a storm drain, send an email ASAP to ReportSligoPollution@fosc.org. Include a brief description (including location and time) and photo. If you see WSSC's work is sending chlorinated water and/or muddy runoff into a storm drain, report the pollution through the email. If you see muddy runoff from a construction site, please report it: unchecked, it can kill aquatic life and it is illegal.
